- Developing and implementing Patient Group Directions
- Statutory Pharmaceutical Needs Assessments for local authorities
- High-cost drug validation and scrutiny of non-payment-byresults (PBR) trust drug-related invoices, Blueteq® and clinical policies
- End-to-end management of pharmaceutical rebate schemes, working with finance and medicines leads to optimise gains.

# 2. Primary Care Networks and clinical medicines optimisation services

We provide professionally registered NHS clinical staff to support general practices implement clinical prescribing support services. These include registered pharmacists and pharmacy technicians with clinical and independent prescribing skills, supported by our wider team to deliver best practice locally.

We also deliver NHS governance and procurement to engage private sector organisations to deliver medicines support locally to offer capacity and delivery to the NHS.

Services can be provided locally or remotely supported by the relevant information governance and data sharing agreements.



#### Inhaler prescribing

## Our range of practice-based services include:

- At-scale Prescription Ordering Direct (POD) services for general practices
- Support for Care Quality Commission (CQC) safety assurance
- Clinical medication review services
- Productive reviews of repeat prescribing systems
- Medicines systems in care homes including our 100-point audit for nurse quality leads in care homes and ICBs.



We are an appointed delivery partner with NHS England to provide the National GP Improvement Programme which is part of Primary Care Access Programme.

We also won an HSJ Patient Safety Award in 2023 for our <u>innovation to reduce</u> <u>inhaler prescribing errors</u>.



### 3. Partnership and programme support

We provide bespoke programme support delivered by project-trained pharmacists and pharmacy technicians with the skills and ability to work with local and national departments to design and deliver innovative outputs.

This has been a growing area of work since 2016 which includes consultancy, project delivery and national support for NHS England and a range of other clients. This work usually involves partnership working with wider departments.

#### **Examples include:**

- Bespoke economic assessment of all NICE guidance for the Isle of Man
- Developing community pharmacy payment systems for Gibraltar Health Authority
- Implementing medicines governance support for Sue Rydar charity
- Partnership working with Health Innovation Networks (formerly known as AHSNs) to deliver atscale uptake of electronic repeat dispensing (eRD).
